# FREE TAX RETURN PREPARATION

If your 2024 household income was \$67,000 or less, you can have your taxes prepared **FOR FREE** by an IRS-certified volunteer at one of several Volunteer Income Tax Assistance (VITA) sites in Corpus Christi.

### WHAT TO EXPECT IF DROPPING OFF

It may take 2-3 weeks to prepare your tax return. Once completed, you will be contacted to schedule an appointment to review and sign your tax return (both spouses must be present to sign joint returns). Your tax documents and a copy of your completed tax return will be provided to you at the end of your appointment.

Your photo ID



Social Security card or individual taxpayer identification number (ITIN) letter for all individuals listed on the return



W-2s, 1099s (including 1099-G for unemployment received if applicable) and all other tax-related documents for 2024



Form 1095-A, B or C Health Insurance Coverage Statement



All 1098 E&T forms for educational expenses



Childcare provider name, address, phone number and tax ID number



Voided check if using direct deposit for refund



Copy of your 2023 return (if possible)

Drop-off sites will also require that you fill out Form 14446 (VITA Virtual Consent) and Form 13614-C (Intake & Interview Sheet).
